This third edition of the multidisciplinary, international and comparative doctoral sessions on the study of movement phenomena (IUF projet "IFITIS") asks what is "the meaning of economic freedoms of movement"?*

It forms part of a two-day event, combining:

- *an international, comparative and multidisciplinary doctoral session (1 half day) – following a public call for contributions*
 - *an international, comparative and multidisciplinary symposium (3 half days) – upon invitation (academics and researchers from Nice, Aix-Marseille, Paris, Germany, Canada, United States, Italy).*

It is organised under the auspices of the Academic Institute of France (IUF), the Côte d'Azur University Law and Political Management Sciences Doctoral School (ED DESPEG), the Law, Economics and Management Research Group of the French National Centre for Scientific Research (GREDEG – CNRS) (main axis Sources and Methodology of Economic Law) and in partnership with the International Economic Law Association (AIDE).

Its aim is to provide a large space for discussion on the capacity of the various disciplines represented (including law, economics, management, philosophy, sociology, history and computer science) to question the meaning (reasons for being, justifications, purposes) of economic freedoms of movement (free trade, international trade and European freedoms of movement).

The event has an inter-generational dimension in that it invites involvement from both young and experienced researchers.

It is international, comparative and multidisciplinary in nature as specialists recognised in their respective domains will participate in accordance with an innovative methodology.

Proposals will be examined by the scientific leads of this event upon the opinion of the scientific committee.

Priority will be given to proposals made in binomial or trinomial form and implying a multidisciplinary and/or comparative crossover approach.
